# 14.30-16.30 Panel 3: Breaking fears and prejudices in the host societies about the migrants, asylum seekers and refugees - comparative perspective

Public opinion polls across Europe reveal rather negative attitudes of local population towards the exiles. Most of the citizens' perceptions are believed to be influenced by ignorance, prejudices, unethical media reporting and populist political discourse. This panel will explore different experiences in countering prejudices and false information surrounding this topic and come up with inspiring examples.

# 16.30-18.00 Panel 4: "Lost generation" -unaccompanied minors' missing childhood on the road

Unaccompanied migrant children appear to spend a sizeable part of their childhood in complete uncertainty: on the road, or awaiting for their asylum requests to be processed or being the victims of human trafficking and abuse. The hosting states appear to be focused much more on administration and procedure, often neglecting the best interests of the child, basic human postulates, and their specific needs. This panel will shed light on this particularly vulnerable category of migrants by pointing to their specificities and what our societies fail to encompass when dealing with these cases.

# 9.30-11.00 Panel 5: Access to employment to the refugees and asylum seekers in Serbia: experiences, challenges and lessons learned

Asylum seekers and persons granted protection in Serbia are facing with serious challenges in accessing labor market, in enjoying guaranteed right to work but also facing challenges in reaching and keeping their employment. APC has been a pioneer in providing legal and psycho-social assistance to the





















asylum seekers and refugees for integration into the labor and empowering them to be competent on the labor market. This panel will explore the experiences and lessons of the conducted activities from the perspective of APC and state institutions, hear the testimonies of the refugees beneficiaries of the assistance as well as hear the testimonies from the countries with more experience in this topic.
