# CEI Cooperation Activity -Conference: DANUBEPARKS Newt Conservation Partnership & Climate Change

**[VĂLENI, REPUBLIC OF MOLDOVA]** – Public Institution Nature Park Kopački rit, Agency Moldsilva and DANUBEPARKS in collaboration with the Central European Initiative (CEI), are proud to announce the upcoming CEI Cooperation Activity - Conference "DANUBEPARKS New Conservation Partnership & Climate Changes." The conference will be held in Văleni, Republic of Moldova, on 30<sup>th</sup> and 31<sup>st</sup> of May 2023.

The conference aims to bring together experts, scientists, and conservationists from the Danube River Network of Protected Areas (DANUBEPARKS) to address the critical issues of newt conservation and climate change. With the support of the CEI Cooperation Fund, this two-day event will provide a platform for knowledge exchange, discussions, and collaborative initiatives to enhance the resilience of the Danube River Basin's biodiversity.

The conference will feature expert meetings, project preparation workshops, and a field trip to the nearby Lower Prut Biosphere Reserve. Participants will have the opportunity to share experiences, best practices, and innovative approaches to conserving newts and amphibians, as well as restoring wetlands as carbon sinks for climate resilience.

"We are excited to host this significant conference, and we are proud that it will be hosted in the Republic of Moldova in the immediate vicinity of the Lower Prut Nature Reserve, one of the "youngest" Protected Areas along the Danube, which was established in 2018." said Dr. Vlatko Rožac, a senior adviser in Kopački rit Nature Park and DANUBEPARKS president. "Through this event, we aim to enhance collaboration, exchange knowledge, and develop effective strategies to safeguard these vital amphibian species and their habitats amidst the challenges posed by climate change."

The event will also serve as a platform to discuss the adaptation of the "Action Plan for the Conservation of the Crested Newt (Triturus cristatus) Species Complex in Europe" specifically for the Danube Region. Moreover, it will pave the way for the initiation of the first Danube-wide Crested Newt conservation project in 2024, further solidifying the commitment of DANUBEPARKS and its partners to long-term conservation efforts.









Attendance to the conference is open to experts, scientists, and stakeholders working in the field of biodiversity conservation and climate change.

Public Institution Nature Park Kopački is Public Body. Main activities are nature conservation, maintenance and promotion of the Nature Park Kopačkirit and the Special Zoological Reserve Kopački rit. As the Kopački rit is placed in the central part of the Danube River and represents the best-preservedfloodplain in the central and upper Danube, it is indispensable for ecological connectivity. Kopački rit was designated as the Ramsar site in 1993 as wellas Important Bird Area. The Nature and Science Department together with the Ranger's service conducts nature monitoring according to theManagement Plan and to the Annual Program of the Institution.
